Breakfast sandwich example:

- a. How does the Rule of Law relate to crossing the street? Trust that people will stop at the stoplight

An individual or a small group of people can't be forced to practice the religion chosen by the majority of people. The law protects everyone's rights in this situation. The majority does NOT rule over the minority when it comes to our inalienable rights.

- People know what they're expected to do and you can hold them to it. They are expected to know, generally, what the laws are
